Location:	<p>No. 1: Stirling Park, 150m west of the intersection of Empire Circuit and Forster Crescent, Yarralumla, Canberra, ACT.</p> <p>No. 2: Royal Canberra Golf Course, adjacent to the former city incinerator, Bentham Street, Yarralumla, Canberra, ACT.</p> <p>No. 3: Off Cotter Road, on the south-western side of its overpass of Tuggeranong Parkway, Weston, Canberra, ACT.</p>

Description:	<p>Brick shafts or chimneys approximately 6.4m x 1.4m square in plan, slightly enlarged at the base, with a rendered or cast concrete top which has four side openings and a concrete slab cap. Heritage listing:	<p>Register of the National Estate.</p> <p>The Register of the National Estate was established under the Australian Heritage Commission Act 1975. This Act has now been repealed but the RNE has been retained under the Heritage Council Act 2003. The Australian Heritage Council will compile and maintain the RNE.</p> <p>(Commonwealth Heritage List – Sewer Vent No. 1).</p> <p>The Commonwealth Heritage List is a list of heritage items or places owned or managed by the Commonwealth Government.</p> <p>The Sewer Vent No. 1 is entered into the CHL as an 'indicative' place, meaning that data has been provided or obtained, and has been entered into the</p>

	<p>database and the place is at some stage in the assessment process. A decision on whether the place should be entered in the CHL has not been made.</p> <p>National Trust of Australia (ACT).</p>
Statutory controls:	<p>Statutory controls apply to heritage items or Conservation Areas. They apply to works in the vicinity of a heritage item or adjacent to a Conservation Area.</p> <p>All vents nominated to ACT Heritage Register. These places are being assessed according to priorities established by the ACT Heritage Council. Any development application that will affect the vents will, however, be referred to the ACT Heritage Council who may delay a decision on the development application and undertake an assessment of the heritage values of the vents.</p> <p>Anyone can apply for an urgent decision by the Heritage Council of a nominated place to protect it under imminent threat, or to avoid delay in a development project. Once it receives the application, the Heritage Council will endeavour to carry out the urgent decision within 20 working days. Applications must be submitted in the appropriate form, this must include a detailed assessment of the place's heritage significance. The Heritage Unit can advise on consultants available and a fee may be charged to recover the Council's costs of the urgent decision.</p>
