

Name:	Glebe Incinerator and Glebe Municipal Depot Sheds

Location:	(End of) Forsyth Street, Glebe, Sydney, NSW.

History:	<p>Designed for the Municipality of Glebe.</p> <p>The incinerator was designed c. April 1932. It operated until 1949 and in 1952, its furnace and flue were demolished.</p> <p>The sheds were constructed in 1934. They were partially demolished.</p> <p>The incinerator and sheds were restored and reinterpreted in 2005. An interpretation of the chimney stack was reconstructed. The sheds were reinterpreted as an open trellis and the six remaining original concrete Hume pipe columns retained.</p> <p>The Glebe Incinerator is one of seven incinerators designed by Griffin that were built in Sydney. Statutory controls:	<p>Statutory controls apply to heritage items or Conservation Areas. They apply to works in the vicinity of a heritage item or adjacent to a Conservation Area.</p> <p>The Glebe Incinerator and Sheds were previously in the Leichhardt Local Government Area (LGA). With</p>

	<p>changes to the LGA boundaries, effective from 8 May 2003, they are now under the jurisdiction of the City of Sydney Council. However, existing planning and heritage controls will continue to apply. Planning controls that have been established by the Leichhardt Council will be enforced by the City of Sydney Council and will be reviewed over time. Any changes will follow the normal public and community consultation processes.</p> <p>Leichhardt Local Environmental Plan 2000 (regional level of significance).</p> <p>Leichhardt Development Control Plan No. 39: Fletchers/Glebe Depot Sites.</p> <p>The Development Control Plan is a guideline document but with no statutory force. Nevertheless, its provisions will be given consideration by the consent authority when making decisions. The DCP provisions are more detailed and are in addition to the provisions of the Local Environmental Plan.</p>
