	The columns are a classical reference, which – seen in today's architectural terms would be 'postmodern', but which in the 1920s was very different from the conventional use of columns in the then popular Colonial Georgian Revival style. Marion Griffin called the house the 'Temple of Aphrodite'.
	Columns or piers, used in evocation of a temple, occur in other Griffin house, including the Grant house, the Rivett house and the Stella James house in Avalon. The column detail is an example of the inventiveness of the Griffins' designs, and the wish to incorporate pre-fabricated elements – in this case Hume concrete pipes – into the houses. In 1920 the Griffin office had designed a house for W. R. Hume, the concrete pipe manufacturer, for a site in Braybrook in Melbourne's western suburbs, not far from the factory.
	A stone garage designed by the Griffin office was added at the front of the Guy House in 1927.
	A bed-sitting room (with small kitchen and bathroom) was added as a second storey in 1963.
