For many different reasons some clients decided not to build their Griffin-designed building, but the client's name still identifies that project. The Incinerator designs were often unbuilt when RIECo's Tender was not the lowest or the Council had a change of mind about building an Incinerator or chose a more suitable site. Many unbuilt Projects suffered their fate due to the Great Depression of the 1930s or the inability of the owner to finance the project. Very few, outside Castlecrag and Canberra, were speculative projects that had no real client. This Table does not include Competition entries by W. B. Griffin or Griffin's unrealised projects in the Australian Capital Territory.
